AED Report to Priston Parish Council, 24th March 2014.

The AED and the public telephone have been inspected weekly since the last Council Meeting. No problems have been found. A written report is tendered to the Parish Clerk every two weeks. Also a report is made at the same time to AED Locator Ltd, who have an overall watching brief over the AED.

I apologise to Council that this report was not to hand before the meeting but I was hoping to have some information on whether Nationwide Building Society were able to help us with training costs but sadly I have nothing to report.

On the training front, two courses have been organised which are suitable as an initiation course or a refresher course. There are 26 villagers who have previously attended a course and now have out of date certification. Currently we have 22 villagers with in date certification.

The course dates are: Wednesday 2nd April at 7.30pm & Saturday 10th May at 2.30pm both to be held in the Village Hall. Places are to be booked through John Wilkinson.

Last but not least, we sadly had a fatal cardiac failure in the Village since the last meeting and there are lessons to be learned from the circumstances of this event.

On enquiry a paramedic in attendance stated that the AED was not registered with the Ambulance Service. I can confirm that the AED was and is registered and the details are on their system.

Although each household has had notification of the cabinet number, this incident was away from the house and the code was not to hand. It has been suggested, and I will implement after this year's courses, that a credit card sized card be produced with the AED code and contact details of people who are Emergency Responders.

I have been told that if the Ambulance Service is notified of an incident from a phone more than 0.25 miles away from the AED they will not advise the caller of the AED cabinet code.
